



Obtaining an EPA Identification Number

What is an EPA Identification Number?

An EPA Identification Number is a unique number assigned to sites that conduct or engage in regulated hazardous waste or used oil activities and is used for tracking purposes by state and federal governments.

The EPA Identification Number is twelve characters long. The first two characters are the postal code for the state, ID for Idaho. The third character can be a letter, such as D or R, or a numeral. The next nine characters are numerals. An example of an Idaho EPA Identification Number is **IDR000123456**. Other combinations of letters and numerals for sites in Idaho are not a valid EPA Identification Number for regulated activities.

EPA Identification Numbers are to be included on the following:

- All shipping manifests for transporting hazardous wastes
- All biennial and annual reports that hazardous waste generators and owners and operators of hazardous waste treatment, storage, and disposal sites must file with DEQ
- All applications for federal hazardous waste permits
- All other hazardous waste management reports and documentation required under
- Subtitle C of RCRA
- You may also be asked for your number by other businesses

Do I already have an EPA Identification Number?

Your site or business in Idaho may have already been assigned an EPA Identification Number. The number may still be valid or you may need to update it before using it. You can update a number with the same form used to obtain a new EPA Identification Number. Who needs an EPA Identification Number?

- Hazardous waste generators (including episodic generators)
- Hazardous waste transporters
- Hazardous waste treatment, storage, and disposal facilities
- Hazardous waste fuel marketers and burners
- Healthcare facilities
- Large quantity universal waste handlers
- Used oil fuel marketers and burners

- Used oil transporters and transfer facilities
- Used oil processors and re-refiners
- Subpart K academic lab activity
- Hazardous secondary material activity
- Recognized trader for hazardous waste exports and/or imports
- E-manifest broker

How do I obtain an EPA Identification Number?

There are two methods for submitting the documentation required to obtain an EPA Identification Number. The preferred method is electronic submission of the 8700-12 RCRA Subtitle C Site Identification Form through RCRAInfo, EPA's comprehensive online information system. The other method to obtain and submit the 8700-12 form is to go to the following URL: <https://rcrapublic.epa.gov/rcrainfoweb/action/main-menu/view> and click on the Site Identification Forms (EPA Form 8700-12) link in the Blue Key Links section or contact the DEQ Hazardous Waste Data Analyst at 208-373-0406 or adam.oliver@deq.idaho.gov. You will need the following information to complete the form:

- Name of your site
- Location and mailing addresses of the site where regulated waste activities are performed
- Land type
- North American Industry Classification System (NAICS) code
- Contact person name, address, email address, and phone number
- Owner's name, contact information, and date of becoming owner
- Operator's name, contact information, and date of becoming operator
- The types of hazardous waste you handle if you are a hazardous waste handler
- The types of other regulated waste activity engaged in or conducting
- Authorized representative signature

Sign and date the notification form, then mail the completed form to DEQ:

It can take up to 2 weeks to obtain an EPA Identification Number in Idaho. In emergency situations, the process can be faster.
