Dear Mr. Mabe:

Following our review and evaluation of the Jim Ford Creek Total Maximum Daily Loads (TMDLs) developed under the Memorandum of Understanding with the Idaho Division of Environmental Quality (IDEQ), the Nez Perce Tribe and the United States Environmental Protection Agency, Region 10, EPA is pleased to approve the TMDLs as follows:

Temperature TMDLs for Upper Jim Ford Creek sub-watershed and Grasshopper Creek. The temperature TMDLs apply during the summer months.

Nutrients and dissolved oxygen TMDLs for Upper Jim Ford Creek sub-watershed and Grasshopper Creek with the exception of those waters which are within Indian country, as defined at 18 USC section 1151. These TMDLs are applicable between April 1 and October 31.

Sedimentation TMDL for Upper Jim Ford Creek sub-watershed with the exception of those waters which are within Indian country, as defined at 18 USC section 1151.

Pathogen TMDL for Upper Jim Ford Creek sub-watershed and Grasshopper Creek with the exception of those waters which are within Indian country, as defined at 18 USC section 1151.

This approval applies to the TMDLs submitted in the document titled "Jim Ford Creek Total Maximum Daily Loads (TMDL)" as submitted to EPA on May 18, 2000.

This approval includes a total of 9 TMDLs for water-quality limited segments on the 1998 303(d) List - 2 TMDLs for temperature, 2 TMDLs for nutrients, 2 TMDLs for dissolved oxygen, 2 TMDL for pathogens, and 1 TMDL for sedimentation.

We appreciate the opportunity to work closely with IDEQ throughout the development of this TMDL. We look forward to hearing of the water quality improvements which result from the implementation of this TMDL and to continuing to work collaboratively with your staff on water quality issues in the Jim Ford Creek watershed.

By EPA's approval, these TMDLs are incorporated into the State's Water Quality Management Plan under Section 303(e) of the Clean Water Act.

In compliance with the provisions of the Clean Water Act, 33 U.S.C. § 1251 et seq., as amended by the Water Quality Act of 1987, P.L. 100-4, the Environmental Protection Agency, the State of Idaho, and the Nez Perce Tribe are jointly establishing Total Maximum Daily Loads (TMDL) for the following §303(d) listed waterbodies (and tributaries) and pollutants in the Jim Ford Creek Watershed.

Jim Ford Creek Watershed Total Maximum Daily Load

Jim Ford Creek #3288	Sediment, Temperature, Nutrients, Dissolved Oxygen, Pathogens (Bacteria)
Grasshopper Creek # 3289	Temperature, Nutrients, Dissolved Oxygen, Pathogens (Bacteria)

These 9 TMDLs have been established to ensure comply with water quality standards which apply to these waters. The joint establishment of these TMDLs does not and shall not be utilized or construed to establish, waive or otherwise affect any claims of sovereignty, jurisdiction, or other authorities of the Environmental Protection Agency, the State of Idaho or the Nez Perce Tribe.

These TMDLs shall become effective immediately.
